New Passport System Application Process

The Citizenship Office wishes to advise all designated agents that we have received a letter on the 5th of August 2024 from the Department of Immigration regarding the new Vanuatu passport system.


This system requires **Personal Enrolment** for any Vanuatu Citizenship Certificate holder meaning that anyone who wishes to apply for Vanuatu passports **MUST** travel to Vanuatu to apply in person. Hence, the new Passport System **requires physical appearance before Immigration and Passport officials for registration of biometric data and facial recognition** and this applies to any person applying for Vanuatu passports that including person(s) applying through the Vanuatu Citizenship Investment programs.

It is vital to note that Vanuatu Passport office will no longer received any paper base passport application after the 31st of August 2024 therefore, Vanuatu Citizenship office & Commission trust that all designated agents of Vanuatu Citizenship Programs will disseminate this information to your sub-agents accordingly.

Installation of the Passport Enrolment Station at Vanuatu Foreign Missions

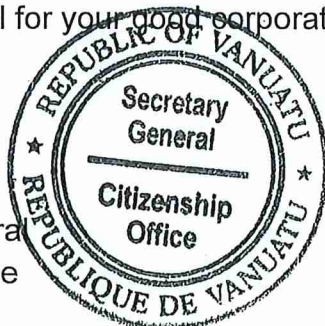

The Citizenship Office and Commission hereby inform ALL that applicants under DSP, VCP and CIIP are allowed to apply for new passport through **Paper Based Application Process**. Such process is currently established following an Immediate Solutions number (4) issued by the Immigration department that Paper Base Application will be applicable until the **end of November 2024**.
